

CSU Higher Degree by Research (HDR) Funding Arrangements

Purpose

This fact sheet provides a breakdown of Higher Degree by Research (HDR) student categories across CSU, the expenses associated with each and the funding source for these.

Scope

This information is relevant for Faculty Executive Officers, Heads of School, Faculty Finance Officers and School administrative staff.

Expenses

There are four main costs associated with HDR candidature, with funding for each being provided either by the Australian Government, or through operational areas of the University.

- 1. **Supervision costs** salaries and related costs of supervisory and administrative staff of the Faculty and/or School. For the purposes of this document this includes overhead and infrastructure costs of these areas. These costs are funded through a variety of sources depending on the fee status of the student.
- 2. **Student support services and amenity costs** costs of University centrally provided services and infrastructure.
- 3. **Operating cost/maintenance allowance** funds provided to the student for use on travel, consumables and research equipment to assist with their chosen research. These costs are funded through a variety of sources depending on the fee status of the student.
- 4. **Stipends** paid directly to the student to assist with their general living expenses. The stipend amount is variable and depends on the scholarship status of the student. Full fee paying students do not receive a stipend.

The table below explains the funding distribution for each category.

2017 changes to Australia Government Scholarships

At the start of 2017 the Australian Government consolidated the existing three streams of HDR Scholarships, the APA, RTS and IPRS into one scheme called the Research Training Program (RTP). Existing APA, RTS and IPRS students maintain an equivalent amount of support, now funded through the Research Training Program. New domestic and international students on Australian Government scholarships are funded from the Research Training Program.
