The Master of Business Administration (Law Enforcement and Security) provides graduates with specialised knowledge and skills in leadership and management in the context of the law enforcement and security professions. The degree is designed to produce inspirational leaders and effective and accountable managers who are able to enhance organisational performance and set and attain organisational strategic goals through sound, ethical practice and innovation.

Normal course duration

Full-time 1.5 years (3.0 sessions)

Admission criteria

CSU Admission Policy

For entry to the Master of Business Administration (Law Enforcement and Security) applicants are required to have an undergraduate degree from a recognised Australian tertiary institution (or equivalent) and appropriate work experience. Applicants without a tertiary qualification may be admitted to the Graduate Certificate in Commerce on the basis of professional attainment and/or work experience. Upon successful completion of the Graduate Certificate, students will then be eligible for admission to the Master Business Administration (Law Enforcement and Security) and receive credit for applicable subjects.

Credit

CSU Credit Policy

Credit into the Master of Business Administration (Law Enforcement and Security) is awarded based on studies completed at postgraduate or equivalent level. Students may receive credit for up to 50% of the course (six 8 point subjects) for studies completed within the last ten years.

No credit will be given for subjects completed at the undergraduate level. However, in some circumstances, candidates may be waived from taking particular subjects, e.g. a candidate with a Bachelor degree majoring in Accounting may be waived from undertaking the Core subject MBA504 Accounting and Financial Management. In such instances, an alternative subject is substituted.

Graduation requirements

To graduate students must satisfactorily complete 96 points.

Course Structure

The twelve subject (96 point) MBA includes subjects divided into three groups. The course structure provides students with the ability to tailor their degree to suit their needs and career aspirations.

Core Subjects: Students need to complete all four Core subjects.

Restricted Elective Subjects (Group A):Students need to complete four of the ten Group A Restricted Elective subjects.
